## Privacy Notice (How we use personal information on get information about schools - GIAS)

This notice explains what personal data (information) we may collect, use, store and share about you. We are required to give you this information under data protection law.

The Oak Partnership Trust is the 'data controller' for the purposes of data protection law.

Our Data Protection Officer (DPO) is Amy Brittan (see 'Contact us' below).

### The categories of governance information that we process include:

We hold some personal information about you when you are a Governor for a school in our Trust. This includes:

- personal information (such as name, address, contact details, gender)
  - qualifications and employment records, including work history, job titles and professional memberships

- DBS Certificate number and date of issue, prohibition from teaching and management checks, disqualification from childcare declaration form
- Special Category characteristics (disability)
- governance details (such as role, start and end dates and governor ID)
- details of governance training booked and attended
- records of attendance at governing body and sub-committee meetings
- if you visit the Trust during a public health emergency, we may also collect some limited information about you as we are required to by law
- CCTV footage captured by OAK CCTV systems

This is not an exhaustive list.

### Why we collect and use governance information

The personal data collected is essential, in order for the Trust to fulfil their official functions and meet legal requirements.

We collect and use governance information, for the following purposes:

- a) to meet the statutory duties placed upon us
- b) to communicate with you about relevant Trust business
- c) to procure appropriate training for you to fulfil your role
- d) facilitate safe appointment of governors, as part of our safeguarding obligations towards pupils

Under the UK General Data Protection Regulation (UK GDPR), the lawful bases we rely on for processing governance information are:

- **Article 6 (c) Legal obligation:** the processing is necessary for us to comply with the law

Some information we process will be Special Category data under Article 9 of UK GDPR e.g. disability. We will rely on the legal basis of **Article 9 (g)** processing is necessary for reasons of substantial public interest.

All academy trusts, under the [Academy Trust Handbook](#) have a legal duty to provide the governance information as detailed above.

### Collecting governance information

We collect personal information via annual contact forms.

Governance data is essential for the Trust's operational use. Whilst the majority of personal information you provide to us is mandatory, some of it may be requested on a voluntary basis. In order to comply with UK GDPR, we will inform you at the point of collection whether you are required to provide certain information to us or if you have a choice in this.

### CCTV

Where CCTV systems are installed on our premises, these are for the purposes of public, pupil and staff safety, crime prevention and detection. Signs are displayed clearly explaining that CCTV is in operation and providing details of who to contact for further information.

We will only disclose CCTV images to others who intend to use the images for the purposes stated above. CCTV images will not be released to the media for entertainment purposes or placed on the internet. Images captured by CCTV will not be kept for longer than necessary. We hold data securely for the set amount of time shown in our data retention schedule.

For more information on our data retention schedule and how we keep your data safe, please see the Data Protection Policy.

### Storing governance information

We hold governance data securely for the set amount of time shown in our data retention schedule which is based on guidance from the Information and Records Management Service (IRMS) <https://irms.org.uk/page/SchoolsToolkit>

We have appropriate security measures in place to prevent personal information from being accidentally lost or used or accessed in an unauthorised way. We limit access to your personal information to those who have a genuine business need to know it. Those processing your information will do so only in an authorised manner and are subject to a duty of confidentiality.

We also have procedures in place to deal with any suspected data security breach. We will notify you and the Information Commissioner's Office of a suspected data security breach where we are legally required to do so.

  - Ofsted

### Why we share governance information

We do not share information about you with anyone without consent unless the law and our policies allow us to do so.

### Department for Education

The Department for Education (DfE) collects personal data from educational settings and local authorities. We are required to share information about you with the Department for Education (DfE), under:

We are required to share information about individuals in governance roles with the (DfE) under the requirements set out in the [Academy Trust Handbook](#)

All data is entered manually on the GIAS system and held by DfE under a combination of software and hardware controls which meet the current [government security policy framework](#).

### Requesting access to your personal data

Under data protection legislation, you have the right to request access to information about them that we hold. To make a request for your personal information, contact our DPO (see 'Contact').

You also have the right to:

- to ask us for access to information about you that we hold
  - to have your personal data rectified, if it is inaccurate or incomplete
  - to request the deletion or removal of personal data where there is no compelling reason for its continued processing
  - to restrict our processing of your personal data (i.e. permitting its storage but no further processing)
  - to object to direct marketing (including profiling) and processing for the purposes of scientific/historical research and statistics
  - not to be subject to decisions based purely on automated processing where it produces a legal or similarly significant effect on you

#### How Government uses your data

The governance data that we lawfully share with the DfE via GIAS:

- will increase the transparency of governance arrangements
- will enable schools and the department to identify more quickly and accurately individuals who are involved in governance and who govern in more than one context
- allows the department to be able to uniquely identify an individual and in a small number of cases conduct checks to confirm their suitability for this important and influential role

**Note:** Some of these personal data items are not publicly available and are encrypted within the GIAS system. Access is restricted to a small number of DfE staff who need to see it in order to fulfil their official duties. The information is for internal purposes only and not shared beyond the department, unless the law allows it.

Under the terms of the Data Protection Act 2018, you're entitled to ask the Department:
